The Jackson County Library Services is looking for a new, permanent logo for the Medford Comic Con! We are in search of community members to design a creative, dynamic, innovative, and original logo that represents the Medford Comic Con. The logo may include abstract symbols or a catchphrase, so long as it fits within the logo itself along with the Medford Comic Con phrase.

The logo should represent the Medford Comic Con mission: *The Medford Comic Con is dedicated to promoting and fostering lifelong learning, connecting people, and celebrating family and community. Our mission is to encourage literacy and innovation through popular media, arts, literature, science & technology, fantasy and science fiction, game play & design in the form of workshops, programming, and exhibitions.*

Medford Comic Con will take place on Saturday and Sunday, April 27-28, 2019.

Contest Rules and Guidelines

How to Enter

The contest begins **September 1, 2018**. Submissions will be accepted through **October 31, 2018**. Winners will be announced through Medford Comic Con (MCC) and Jackson County Library Services (JCLS) social media, website, and direct contact with the winning designer by Sunday, November 18, 2018.

All entries:

1. Can be submitted online through the jcls.org/mcc website, or directly to Central Art Supply (101 North Central Ave, Medford OR 97501), attention Ann Ebert and Adam Bunch: ann@centralartsupply.com adam@centralartsupply.com
2. In the original source file
3. As high resolution 300 dpi or higher

There is no fee to enter.

Requirements/Submission Guidelines

The winning logo of the MCC Logo Contest will be used online, in print, on merchandise, and for all needs the logo may serve for MCC and JCLS.

- The logo must promote and represent the mission of the Medford Comic Con.
- There are no limitations to the use of color in the logo, however the logo must look good in both color and black and white.
- Logos must be original artwork. Logos must not contain copyrighted material. Logos may not include previously published or licensed images and must be reproducible at large and small formatting. Previously designed original artwork from the artist is acceptable if it has not been and will not be reproduced in other venues or purposes.
- No more than 3 entries per entrant

Details

‘Entry’ is defined as a logo design created by the Entrant for the MCC Logo Contest.

‘Entrant’ is defined as an individual that offers the Entry under the terms of the MCC Logo Contest.

The MCC Logo Contest Winner will be selected by the MCC planning committee. Contestants agree that Jackson County Library District, Central Art Supply, and Medford Comic Con may publish their logo and names, and the logo may be used for advertising and marketing materials in the future. Contestants assign all ownership rights, including all intellectual property rights to the logo, to the Medford Comic Con (MCC), as part of Jackson County Library District (JCLD). MCC and JCLD may modify, alter, or revise the logo as needed to fulfill the mission of MCC. In its sole discretion, MCC reserves the right to not select a winner if no suitable entries are received.

Prize

The MCC Logo Contest Winner will receive recognition through MCC, the Jackson County Library District (JCLD), JCLS, and What To Do In Southern Oregon social media, as well as:

- Swag Gift Bag and \$100 Gift Card from Central Art Supply for the first year
- Courtesy samples of all items the logo is used on for the first year (except banners)
- Free Vendor Table for the following 5 years at MCC
 - Online promotion of Vendor Table for the following 5 years at MCC
- Online promotion of graphic design business (if applicable) for first year
- Recognition on Sponsor list online and on official banner (personal logos may be submitted for Sponsor recognition)

Acceptance

Entry into the MCC Logo Contest constitutes full and unconditional agreement to and acceptance of these Contest Rules and Guidelines. By participating in the MCC Logo Contest, the Entrant is representing and warranting that she/he has read and understood, and agrees to be bound by, these Contest Rules and Guidelines which constitute the entire agreement between the Entrant and JCLD, JCLS, MCC, and Central Art Supply in relation to the MCC Logo Contest. These Contest Rules and

Guidelines govern the Entrant's participation and supersede any prior or other agreements between the Entrant and MCC and relating to the Contest. In the event that MCC discontinues, all rights remain reserved with JCLD, JCLS, and MCC. If MCC is reestablished, any of the above prizes not met prior to discontinuation will be retroactive from the last event held.

Representations and Warranties

By participating in the MCC Logo Contest, the Entrant warrants and represents in connection with the Entry submitted as part of Entrant's participation in the Contest: (a) he/she is the sole and exclusive owner of all intellectual property rights in and to the Entry free and clear of any adverse claim by any third party; (b) the Entry is original and the use of the Entry as described in these Contest Rules and Guidelines will not infringe the proprietary rights, including without limitation the intellectual property rights, of any third party; (c) the use of the Entry, as described in these Contest Rules and Guidelines, will be in compliance with any third-party licenses pertaining to the Entry; (d) the Entry is not obscene or libelous, and does not violate any rights of any third party, including but not limited to rights of privacy or publicity; (e) the Entry does not contain any virus, spyware, malware, trap door, worm, or any other device, mechanism or code that is injurious or damaging to software or hardware used in conjunction with the Entry; (f) the Entry and its use as described in these Official Rules will not violate any federal, county, state or local laws or ordinances; (g) no employer or educational or other establishment has any rights in the Entry; (h) the Entry is consistent with these Contest Rules and Guidelines; and (i) she/he has the right to grant the license to MCC, JCLD, and JCLS as required in these Contest Rules and Guidelines.

Severability

If any term or provision of these Contest Rules and Guidelines is determined to be invalid or unenforceable for any reason, such term or provision shall be severed from these Contest Rules and Guidelines without affecting the validity or enforceability of the remainder of these Contest Rules and Guidelines.

Governing Law and Venue

These Contest Rules and Guidelines shall be governed by and construed in accordance with the laws of the State of Oregon, without regard to its conflict of laws provisions. Any action or proceeding brought to enforce or otherwise arising out of or related to these Contest Rules and Guidelines or the MCC Logo Competition shall be commenced and maintained only in the Circuit Court of Jackson County, Oregon.

Indemnity; Disclaimer of warranties; Limitation of Liability

By participating in the MCC Logo Contest, the Entrant agrees to be bound by these Contest Rules and Guidelines, including all eligibility requirements and all decisions of MCC, JCLD, JCLS, and Central Art Supply. By participating in the MCC Logo Contest, Entrant agrees to indemnify, defend, and hold harmless MCC, JCLD, JCLS, and Central Art Supply, and their officers, agents, affiliates, contractors, contributors, subsidiaries, licensors, distributors, and assigns ("JCLD Entities") from any and all liability, claims, or actions of any kind arising out of: (i) Entrant's breach of any representation, warranty or covenant made by Entrant in connection with these in these Contest Rules and

Guidelines; (ii) Entrant's participation in the MCC Logo Contest; (iii) Entrant's acceptance and/or use or misuse of any prize in connection with the MCC Logo Contest; and/or (iv) any third party claim relating to any rights or claim of right asserted in any Entry or component of any Entry submitted by Entrant.

BY PARTICIPATING IN THE CONTEST, THE ENTRANT AGREES THAT MCC, JCLD, JCLS, AND CENTRAL ART SUPPLY ENTITIES MAKE NO WARRANTY, REPRESENTATION, OR GUARANTEE OF ANY KIND, EXPRESSED OR IMPLIED, IN FACT OR IN LAW, RELATING TO THE CONTEST AND/OR THE PRIZES.

By participating in the Contest, the Entrant agrees that MCC, JCLD, and Central Art Supply is not responsible, and will in no event be held liable, for any: (i) lost, late, illegible, misdirected, damaged, incomplete, corrupted or garbled entries; (ii) telephone, computer, or network malfunction or error; (iii) communication disruption or other disruptions related to Internet traffic, virus, bug, worm, or non-authorized intervention; or (iv) damage caused by a computer virus or otherwise resulting to any computer from the submission of entries. MCC, JCLD, and Central Art Supply reserve the right to disqualify any unauthorized entries, including, without limitation, multiple entries from the same person, or any entries made through robotic, automatic, mechanical, programmed or similar multiple-entry, or entry duplication, method and to disqualify any person or entity using such a method.
